Keynotes and Distinguished Speakers



I Gusti Agung SUMANATHA, Justice of the Supreme Court, Republic of Indonesia

He was firstly appointed as a Justice on March 2013 and sitting in the civil chamber. He was born in Denpasar, Province of Bali – Indonesia, on 22 March 1956. He graduated with Bachelor of Laws from Gajah Mada University – Indonesia in 1982, and was graduated for Master of Laws from Gajah Mada University – Indonesia in 2011. Justice I Gusti Agung Sumanatha, started working as candidate judge in first instance court, District court of Kebumen - Central Java, and was sworn in as a judge for the court of the first instance assigned to the District Court of Jeneponto – South Sulawesi in 1986, and from then on he has been assigned respectively to the district court of Cibadak – West Java in 1991, appointed as coordinator assistant of the Chief Justice of Supreme Court of RI in 1995, in 2001 as a Judge in District Court of Central Jakarta. He was sworn in as an appellate court Judge to Jakarta High Court in 2007 and assigned as secretary of the Judicial Training Center of The Supreme Court of RI in 2006. He was last appointed as the Director of the Judicial Training Center on Technical Matters of the Supreme Court of RI in 2010.



Freddy HARRIS, Director General of Intellectual Property, Ministry of Law and Human Rights, Republic of Indonesia

Dr. Freddy Harris is the Director General of Intellectual Property, Ministry of Law and Human Rights of the Republic of Indonesia since November 2017. His educational field of study were on Corporate and Bankruptcy Law, Contract Drafting Law, Cyber Law, Intellectual Property Rights Law and System Analyst. He graduated the Bachelor of Law at University of Indonesia in 1992. He took his Master of Law on Rijks Universiteit Groningen, NETHERLANDS in 1998. In 2004 he got his Accredited Diploma for Cyber Crime Studies in Perbanas Institute. Then he got his Doctoral Degree as Doctor of Legal Studies in University of Indonesia in the year of 2007. His experience in the Private sector was Assistant of HRD Manager at Fasa Bumi Laksana Group, Legal Manager at Fasa Bumi Laksana Group, Counselor at Law HAEYS IT Legal Consultant, Partner at Erman Kurnia Freddy Counselor at Law, Board of Supervisory of Indonesia Domain Name Management (PANDI), and now he is also one of the commissioners on Indonesian Railways Company (PT. KAI). In the government sector he was Vice

Dean for Student Affairs and Alumni , Faculty of Law, University of Indonesia; Head of Institution for Legal Studies and Technology, University of Indonesia; Head of IPR Clinic, University of Indonesia; Head of Trademark Appeal Commission of the Republic of Indonesia; Director of Information Technology, DGIPR; Secretary of Directorate General of Legal Administrative Affairs and the Director General of Legal Administrative Affairs.



Razilu, Senior Advisor, Economic Affairs, Ministry of Law and Human Rights, Republic of Indonesia

Razilu is currently Senior Advisor for Economic Affairs for the Ministry of Law and Human Rights of Indonesia. Before his appointment as Echelon I official in 2018, he filled the position as a Patent Director and IP Technology Information Director of DGIP (Directorate General of Intellectual Property). Agus SARDJONO, Faculty of Law, Universitas Indonesia

Prof. Dr. Agus Sardjono is a lecturer and researcher at the Faculty of Law, Universitas Indonesia. He specializes in Commercial Law & IP Law. His primary area of research is Indonesian Business Law & Intellectual Property Law, an area in which he has been actively involved since 1989. He obtained a PhD in Law from the Universitas Indonesia, is an alumnus of the joint LLM organized by the WIPO Academy and the University of Turin, where he attended his Post-graduate Advance IP Courses, and was a research fellow at Tokyo University, Japan. Together with fellow researchers from American University, New York University, Cambridge University, North Carolina University, Brown University, Social Science Research Council, New York, and Indonesian NGO's, he conducted research on IPR and Traditional Cultural Expression in many regions throughout Indonesia. He has authored several books and journal articles in the commercial and intellectual property law areas. In particular, he has published books on (1) Intellectual Property Laws and Traditional Knowledge, (2) Copyright in Graphic Design, and (3) Down to Earth IP in Indonesia. He is also the author of numerous papers on Commercial Law and IPR. He has been invited as an examiner of dissertation in the PhD Programme of The University of Technology Sydney. In addition to his scholarly work, he has served as expert witness in several intellectual property cases and led a team to write academic draft of law related to intellectual property and traditional knowledge. He is currently the head of legal division of PAPPRI, a union for Indonesian musician. Being a musician at heart, he has composed several songs, including the WIPO song.



Mohamed Abderraouf BDIQUI, WIPO Academy, World Intellectual Property Organization

Mohamed Abderraouf Bdioui is a Senior Counsellor of Management, Strategic Planning and Coordination Program, World Intellectual Property Organization (WIPO) Academy. In this role, he facilitates the Academy's management, participates in outlining the Academy's policies and programs, coordinates its activities, and builds up partnerships and cooperation arrangements. Before joining WIPO, in 2011, he was Minister Plenipotentiary at the Tunisian Ministry of Foreign Affairs and headed WIPO, WTO, WHO, UNCTAD and UNDP desks. He was also Consul and Economic attaché at the Tunisian Embassy in Beijing for the period from 1996 to 2003 and served at the Permanent Mission of

Tunisia in Geneva from 2006 to 2011. Mr. Bdioui participated in several bilateral and multilateral discussions and conferences, including the Middle East Peace Process negotiations in the early 1990's, and contributed in the organization of the World Summit on the Information Society in 2003 in Geneva and in 2005 in Tunis. He chaired a number of official WIPO meetings, including the 47th and 48th Series of Meetings of the WIPO General Assemblies, the 61st and 62nd Sessions of the WIPO Coordination Committee and the 4th and 5th Sessions of the WIPO Committee on Development and Intellectual Property (CDIP). He also led several WIPO education and training initiatives, including the Judicial Training Institutions Project, which focused on building the capacity of national judicial training institutions in four pilot countries (2017-2019). Mr. Bdioui studied at the University of Tunis, the Mediterranean Academy of Diplomatic Studies and the National School of Administration in Paris and in Tunis. He holds a Master's degree in international relations and university degrees in law, pedagogy and translation.



Antony TAUBMAN, Intellectual Property, Government Procurement and Competition Division, World Trade Organization

Antony Taubman has served since 2009 as Director of the WTO's Intellectual Property, Government Procurement and Competition Division. From 2002 to 2009, he directed the Global Intellectual Property Issues Division of WIPO (including the Traditional Knowledge Division and Life Sciences Program). A diplomatic career with the Australian Department of Foreign Affairs and Trade (DFAT) concluded with service as Director, International Intellectual Property, engaged in multilateral and bilateral negotiations on IP issues, domestic policy development, regional cooperation, and TRIPS dispute settlement. Earlier service included disarmament policy and participation in the negotiations on the Chemical Weapons Convention, and postings to the Australian Embassy in Tehran as Deputy Head of Mission, and to the Hague as Alternate Representative to the Preparatory Commission for the Organisation for the Prohibition of Chemical Weapons and Chair of the Expert Group on Confidentiality. In 2001 he joined the Australian Centre for Intellectual Property in Agriculture and the College of Law at the Australian National University, teaching and researching on international IP law. He has held postgraduate teaching appointments at several universities including at the University of Melbourne, the Queensland University of Technology and the University of Edinburgh, and contributes to many other educational and training programs. In 2008, the Rockefeller Foundation awarded him a Bellagio residential fellowship for his work on TRIPS and public policy issues. He has authored numerous publications on the TRIPS Agreement and international IP law and policy and cognate policy fields. An earlier appointment at WIPO covered development cooperation in Asia and the Pacific, redesign of the program and budget, and policy development. A registered patent attorney, he worked in private practice in the law of patents, trademarks and designs in Melbourne in the 1980s. His tertiary education has included computer science, mathematics, engineering, classical languages, philosophy, international relations and law; he taught ancient Greek philosophy at Melbourne University.



Irene CALBOLI, Texas A&M University School of Law

Irene Calboli is Professor of Law at Texas A&M University School of Law, Academic Fellow at the School of Law, University of Geneva, Visiting Professor at Nanyang Business School, Nanyang Technological University, Senior Fellow at Melbourne Law School, Transatlantic Technology Law Fellow at Stanford Law School, and Distinguished Fellow at the Royal University of Law and Economics in Phnom Penh (Cambodia). She has held visiting and full-time academic positions in several universities, including National University of Singapore, International Islamic University Malaysia, Bocconi University, Hanken School of Economics, Hebrew University, King's College London, the University of Strasburg, Tongji University, the University of California at Berkeley, and the Max-Planck Institute. Most recently, she was Lee Kong Chian Fellow and Visiting Professor at Singapore Management University School of Law, where she headed the Applied Research Centre for Intellectual Assets and the Law in Asia from 2015 until 2017. Amongst her initiatives in Singapore, she founded the IPScholars Asia Conference (now renamed Asian IP-Works in Progress Conference) and the ASEAN IP Colloquium. She is also the founder of the IP & Innovation Researchers of Asia Network, an academic network established in 2018. Irene is the author and editor of several well-known books, and her articles and chapters have appeared in leading volumes, peer reviewed journals, and student edited law reviews. She is currently a member of the Editorial Board of the *Queen Mary Journal of Intellectual Property*, the *Oxford Journal of Intellectual Property Law and Practice*, and the WIPO-WTO Colloquium Papers, and a past member of the Editorial Board of the *Trademark Reporter*. An elected member of the American Law Institute, Irene regularly acts as Expert for national governments and international organizations, and has recently conducted missions for the World Intellectual Property Organization, the EU Commission, the EU Intellectual Property Office, the Intellectual Property Office of Ethiopia, and the Intellectual Property Office of Singapore. For the period 2017-2020 she has been awarded the Fulbright Specialist status.



Jacques DE WERRA, School of Law, University of Geneva

Jacques de Werra is professor of contract law and intellectual property law at the School of Law of the University of Geneva, Switzerland since 2006. From 2015 until 2019, he was also a Vice-Rector in charge of leading, among other missions, the University's digital strategy. He authored a doctoral thesis in Swiss and comparative copyright law which he completed as a visiting scholar at the Max-Planck Institute for Intellectual Property, Competition and Tax Law in Munich in 1996. He has practiced law in Switzerland, before obtaining an LL.M. degree from Columbia Law School in New York City in 2001 and being admitted to the New York bar in 2002. He was a Faculty Fellow (2012-2013) and a Faculty

Associate at the Berkman Center for Internet and Society (2013-2014) and has held visiting professor positions at Stanford Law School, Nagoya University and City University of Hong Kong. Jacques de Werra researches, publishes and speaks on intellectual property law, contract law and Internet, IT and technology law. He has developed a particular expertise in IP commercial law including transfer of technology, licensing and franchising, as well as in alternative dispute resolution mechanisms for IP and technology disputes (specifically arbitration). He has widely published in leading law reviews (including the Harvard Journal of Law and Technology and the Columbia VLA Journal of Law and the Arts) and has authored / edited various books of reference including a Research Handbook on Intellectual Property Licensing (Edward Elgar 2013) and (in co-edition with Prof. Irene Calboli) the Law and Practice of Trademark Transactions (Edward Elgar 2016). He is the coordinator for the University of Geneva of the joint WIPO-University of Geneva Summer School on Intellectual Property and of the University of Geneva Summer School on Digital Law. Jacques de Werra is the scientific editor of an IP books series, in which the proceedings of annual intellectual property law conferences held at the University of Geneva are published.

Kiyoshi ADACHI, National Graduate Institute for Policy Studies

Kiyoshi Adachi has been a Visiting Scholar with the National Graduate Institute for Policy Studies in Tokyo, Japan since 2015 where he has been conducting research on issues related to trade and investment agreements, intellectual property and emerging public health issues. He has lectured on these topics at the GRIPS Summer SciREX Summer Camp and the GRIPS Innovation Science and Technology lecture series, as well as at the University of Tokyo's Graduate School of Public Policy Research Seminar Series and the United Nations University (UNU) Intensive Course on the UN System and Sustainable Development. In addition to numerous United Nations publications, he has published chapters and articles, including with Oxford University Press in *Megaregulation Contested: Global Economic Ordering after TPP*. Between 2016 and 2018, Mr. Adachi was concurrently a Visiting Fellow with the UNU Centre for Policy Research. He is also a Legal Officer of the Intellectual Property Unit, Division on Investment and Enterprise, United Nations Conference on Trade and Development (UNCTAD) where, since 2006, has led a team of lawyers looking into the integrated treatment of intellectual property, technology transfer and development issues. Prior to joining UNCTAD, he worked with the United Nations in New York and Vienna, and with an international law firm in Tokyo. Mr. Adachi holds a *Juris Doctor* from the UCLA School of Law and is admitted to the bars of Pennsylvania and the District of Columbia, USA.



Martin ADELMAN, George Washington University Law School

Professor Adelman is currently the Theodore and James Pedas Family Professor of Intellectual Property and Technology Law, Co-Director of the Intellectual Property Program and Co-Director of the Dean Dinwoodey Center for Intellectual Property Studies at the George Washington University Law School.

Before joining George Washington in 1999, Professor Adelman was a professor of law at Wayne State University Law School. Prior to joining Wayne State he practiced as a patent attorney in the Detroit area for several years. The current focus of his teaching and scholarship is in the field of patent law. He has written many law review articles on patent law, the economics of patent law and patent-antitrust law. From 1977 to 1988 he was one of the co-authors and from 1988-2013 the sole author of the continuously updated nine volume treatise on patent law entitled *Patent Law Perspectives* (Matthew Bender). He is also a co-author of various other books like *Cases and Materials on Patent Law*, 5th ed. (West 1998, 2003, 2009, 2014, 2019). He has testified either by deposition or at trial as an expert in patent law and practice in more than 190 cases and he has lectured widely on patent law subjects at conferences across the world. He has taught or is currently teaching patent law at the Munich Intellectual Property Law Center, the Hebrew University of Jerusalem, Bar-Ilan University, and the University of Washington.



Christian ANDERSEN, Faculty of Law, Maranatha Christian University

Christian Andersen is a lecturer at Maranatha Christian University, Faculty of Law, and teaches Contract, Intellectual Property, and Cyber law. He was a tutor of Ethics and Business Law in School of Business Management, Institute Teknologi Bandung. He has been working as a permanent lecturer for Maranatha since 2010 and is in charge of thesis defense, student affair and coach of legal drafting student unit. He has authored various articles published by local and international journals.\



Samuel ANDREWS, School of Law, University of Gondar

Samuel is a Professor of IP Law and USA Ambassador's Distinguished Scholar at University of Gondar School of Law, Ethiopia. He holds an SJD from Suffolk University Law School, USA. He also holds an LL.M in Jurisprudence, International Law and Legal Theory and an LL. B (Hons), both from the University of Uyo, Nigeria. He is a Barrister-at-law in Nigeria. His recent scholarly work includes 'Re-conceptualizing International Copyright Law to Protect African Creative Industries' (2018) and 'Reforming Copyright Law for A Developing Africa' J. Copyright Soc'y USA (forthcoming). His recent scholarly presentation

She coordinates the Intellectual Property Post-Graduate Program in cooperation with Universitas Indonesia and WIPO Intellectual Property Academy, and leads the Intellectual Property Centre on Regulation and Application Studies in the Department of Law on Information Technology and Intellectual Property, Faculty of Law, Universitas Padjadjaran. Her main interest is in the area of new emerging IPRs, especially genetic resources, traditional knowledge and cultural expressions, geographical indications and collective management organizations for author's rights, related rights and geographical indications. She serves in the Cultural Assembly of West Java Province, the Senate of the Republic of Indonesia, the Ministry of Environment and Forestry, the Ministry of Justice and Human

Rights, the Ministry of Foreign Affairs and the Ministry of Industry to draft new laws and implementing regulations related to Intellectual Property Rights. She was appointed as a vice head of Indonesian Trade Marks Appeal Commission from 2011 to 2014 and a Commissioner of the National Collective Management Organization of Authors and Related Rights from 2015 to 2018.



Sathyan BALACHANDRAN, Tamil Nadu National Law University

Sathyan has an experience of five years of teaching experience as Assistant Professor of Economics in Tamil Nadu National Law University, Tiruchirappalli, Tamil Nadu. He is on leave from Jindal Global Law School in India, where he serves as Assistant Professor and heads the Centre for IP & Technology Law. He is also a visiting lecturer at Bucerius Law School, Germany. Arpan's main areas of interest are IP law (focusing on copyright and trade mark law), media law and entertainment law. He has published widely and received various grants and awards. In recent years, his accomplishments and engagements include being awarded the Alexander von Humboldt Foundation German Chancellor Fellowship, being co-awarded the British Academy Leverhulme Small Research Grant, being selected for the Stanford Law School-University of Pennsylvania International Junior Faculty Forum, and winning the ATRIP writing prize for young scholars. Prior to joining Jindal, he taught at the Indian Institute of Technology, Kharagpur. Before joining academia, he practiced as an IP lawyer in India, working on a broad range of contentious and non-contentious matters.



Muhammad Masum BILLAH, College of Law, Sultan Qaboos University

Dr. Muhammad is an Assistant Professor at Sultan Qaboos University, Oman. He has recently published two papers on copyright law. They appeared in *Chicago-Kent Journal of Intellectual Property*, ((2018) v. 17.2 pp. 422-448) and in *The John Marshall Review of Intellectual Property Review* (2018). He has taught intellectual property law over many years to his students. Dr. Muhammad has published other papers and one book in other areas of law including maritime law, Islamic banking and finance, and racial profiling. His book, *Effects of Insurance on Maritime Liability Law: A Legal and Economic Analysis*, was published in 2014 by Springer (Switzerland).
