# Biographies

## Opening Remarks



### **Bernard ONG, Intellectual Property Office of Singapore**

Bernard Ong is the Assistant Chief Executive, Policy and Engagement, at the Intellectual Property Office of Singapore (IPOS). Bernard completed the Advanced Management Program at Harvard Business School in 2022. He obtained his PhD at Waseda University, Japan after graduating in economics from the National University of Singapore. He was also a Fellow at the Global Institute for Asian Regional Integration and taught “FTAs and East Asia” at Waseda University. Prior to joining IPOS, he held a range of portfolios in international research and engagement for the Singapore Government covering sectors including defence, education, manpower and statistics.



### **Irene CALBOLI, IPIRA Network; Texas A&M University School of Law**

Irene Calboli is the Executive Director of the IPIRA Network. She is Regents Professor of Law at Texas A&M University. She holds several honorary and visiting appointments, including at Singapore University of Social Sciences, the University of Geneva, Sciences Po Paris, the University of Melbourne, National Law School Delhi, Bocconi University, and the Royal University of Law and Economics of Cambodia. She is a past Fulbright-Hanken Distinguished Chair in Business and Economics and a Fulbright Specialist. She regularly advises national governments and IP Offices and is an Expert for the World Intellectual Property Organization, the World Trade Organization, and the UN International Trade Center. She has designed and implemented programs for technical assistance and professional training across every continent. She is an elected member of the International Academy of Comparative Law, the American Law Institute, and the European Law Institute.

## Speakers (In Order of Presentation)



### **Wayne Wei WANG, FGV Center for Technology and Society**

Wayne Wei Wang is a Non-Resident Fellow at the FGV Center for Technology and Society (Brazil), an ACCP Fellow at the African Center for Cyberlaw and Cybercrime Prevention (Nelson Mandela University, South Africa), and a Research Fellow (by courtesy) at the Center for Artificial Intelligence Law, GDUFE (China). He recently completed his Ph.D. in Law and Technology at the University of Hong Kong. With a background in both Engineering and Law, Wayne's research examines Intellectual Property, Data Protection, AI Governance, and Science & Technology Studies—emphasizing Law, Innovation, Sustainability, and Technology (LIST) in the context of the Automating Global South. His work has appeared in journals such as *Computer Law & Security Review*, *Journal of AI Law & Regulation*, *Chinese Journal of Cyber and Information Law*, and *African Journal of Information & Communication*, and in (forthcoming) volumes from Oxford, Cambridge, and Routledge. He holds an LLM in IP from the WIPO-QUT program (Australia) as a Dean's Scholar and is an Associate Fellow of Advance HE (UK). Wayne is active in networks including GigaNet and APSN, and contributes to the UN Internet Governance Forum's Dynamic Coalition on Data and AI Governance. His honors include the 2025 PTC Emerging Scholar Award and fellowships across five continents.



### **Ida Madieha binti Abdul Ghani AZMI, International Islamic University Malaysia**

Professor Dr Ida Madieha Abdul Ghani Azmi is a leading academic in Intellectual Property (IP) Law and Cyberlaw. She is currently Dean of the Ahmad Ibrahim Kulliyah of Laws at the International Islamic University Malaysia (IIUM) and formerly served as Dean of the Centre for Postgraduate Studies (2019–2023). She holds an LL.B (Hons) from IIUM, an LL.M from the University of Cambridge, and a Ph.D. from the University of London. She has held several prestigious fellowships, including the Fulbright Master Scholarship, Max Planck Research Scholarship, and the Commonwealth Fellowship, with academic engagements at Monash, Nottingham, Cambridge, Queen Mary, George Washington, American University, and the Max Planck Institute for Innovation and Competition. Dr Ida has played a key advisory role in national and international legal reform. She was the lead consultant in drafting Malaysia's Cybersecurity Act 2024, Data Sharing Act 2025, and the National Guidelines on Intellectual Property and Competition (2017–2018). As a consultant to the World Intellectual Property Organization (WIPO), she contributed to several major initiatives: drafting IP

modules for MyIPO Malaysia (2017); formulating the IP Policy for Kathmandu University, Nepal (2016); developing the IP curriculum and syllabus for Bangladesh (2014); designing a database of copyright law and policy for ASEAN countries (2022); and preparing a model copyright curriculum for arts and culture schools in developing countries (2022). She also served two terms on the Board of MyIPO, was Deputy Director of the Malaysian Copyright Tribunal, and currently serves as a Domain Name Panellist with the AIAC.



**Althaf MARSOOF, Nanyang Technological University**

Althaf Marsoof is an Associate Professor at the Division of Business Law of Nanyang Business School, Nanyang Technological University, Singapore. He currently serves as the Deputy Head of the Business Law Division and as a Fellow of NTU's Renaissance Engineering Programme. Althaf holds a BSc in information technology from Curtin University, an LLM from the University of Cambridge and an MPhil from the University of Queensland. Prior to joining NTU in 2017, he was awarded a PhD from the Dickson Poon School of Law, King's College London. Althaf specializes in intellectual property and technology law. He has published his research in reputable journals, including the International Journal of Law & Information Technology, International Review of Intellectual Property & Competition Law, Intellectual Property Quarterly, and the European Intellectual Property Review. Before transitioning into academia, he served the Government of Sri Lanka as a State Counsel attached to the Attorney General's Department.



**Le MA, East China University of Political Science and Law**

Le Ma, graduated from Jilin University School of Law with LLB, LLM and PHD, is currently a Professor and Associate Dean of the School of Foreign Affairs and Law at East China University of Political Science and Law (ECUPL), specialized in International Law and Intellectual Property Law. He has been widely involved in international colloquiums like the Annual Conference of the European China Law Studies Association (ECLS), Brazilian Intellectual Property Association's (ABPI) International Congress on Intellectual Property, Asian Law Institute (ASLI) Conference and IP & Innovation Researchers of Asia (IPIRA) Conference as a presenter on IP issues concerning China. He is also a member of the Scientific Committee of the IPIRA Conference. He gives lectures at the WIPO China IP Summer School. Prof Le Ma had been assigned as the Assistant Judge in the IP Court of the People's Court of Pudong New District, Shanghai, China. He was the Visiting Professor of the University of San Francisco School of Law, as well as the visiting scholar of Macquarie University and

Queensland University of Technology. He also serves as an arbitrator in esteemed arbitration institutions such as HKIAC and SHAC.



**Laina RAFIANTI, Universitas Padjadjaran**

Dr Laina Rafianti, S.H., M.H. is an Associate Professor at the Faculty of Law, Universitas Padjadjaran, where she has taught Intellectual Property Law, Media Law, and International Contract Law since 2005. She earned her Bachelor's, Master's, and Doctoral degrees in law from Universitas Padjadjaran, graduating *cum laude*. Her doctoral research focused on the protection and digitalization of Traditional Cultural Expressions (TCEs). Dr Rafianti is actively involved with the Center for Regulatory Studies and Intellectual Property Application, where her research focuses on copyright and traditional cultural expressions. She is a member of the Intellectual Property Rights Teaching Association in Indonesia and participates regularly in international academic networks, including the Intellectual Property & Innovation Researchers of Asia (IPIRA). She has also taken part in numerous IP-related training programs, such as the Geographical Indication Training, the Asia-Pacific Workshop on Innovation, IP, and Competition at National Law University in India, and the WIPO-WTO Colloquium Asia. In addition to her academic work, Dr Rafianti recently supported the West Java Cultural and Tourism Office in preparing an inscription for Indonesia's National Intangible Cultural Heritage.



**Le HA, Foreign Trade University**

Associate Professor Le Thi Thu Ha has 20 years of experience in researching, teaching and consulting on challenges of enterprises to support improving the competitiveness of startups, companies and products through creating intellectual property, encouraging innovation, and branding. As the current Director of FTU Innovation and Incubation Space, Prof Le has led the key activities of FTU in innovation, such as developing a new curriculum in E&I, inspiring innovative and entrepreneurial spirit in the Vietnamese young generation, and managing Intellectual Property-focused projects with innovative, community-oriented and sustainable solutions in the last few years. FTU has become the pioneer university in the national innovation ecosystem, organized by VCCI, Vietnam and the most impactful institution in the global innovation competition "Social Business Creation", initiated by HEC, Canada (Haute Etudes de Montréal) in 2021 and 2022. As the first chairwomen of the Vietnam Network of Higher Education E&I Center (VNEI), Ms Le Ha plays an important role in promoting the innovation activities in universities and colleges, creating new initiatives influencing the

widespread network and laying a solid foundation for new policies in innovation being practically applied in academic life. As the leader of the Innovation and Intellectual Property Research Team at FTU, Prof. Le has followed the impact trend in transdisciplinary research and received research funding from international organizations and enterprises, such as WIPO, UNwomen, WTI, and Mitsubishi Corporation. Besides, she participated as an independent consultant in many projects funded by NGOs, international organizations and the Vietnamese Government. Prof Le is a pioneer in raising awareness of intellectual property and innovation among young people, start-ups, the business community, and policymakers.

### **Lihini DE SILVA, General Sir John Kotelawala Defence University**

Lihini Madushika De Silva currently serves as the Head of the Department of Public Law, at Faculty of Law, General Sir John Kotelawala Defence University (KDU), Sri Lanka. She holds the degree of Master of Philosophy (MPhil) in the area of Intellectual Property Law from University of Colombo, and she obtained her LLB (Hons) degree from Faculty of Law, University of Colombo, Sri Lanka. She was awarded the A.B. Cooray Memorial Prize for the academic excellence from the University of Colombo at the undergraduate level. Lihini is also an Attorney-at-Law of the Supreme Court of Sri Lanka. She has presented a number of research papers at local and international research conferences and won the Best Research Award for the presented papers on several occasions. Lihini's research focus on Intellectual Property Law with a special emphasis on the areas of Geographical Indications Law, Patent Law and Trade Secret Law and she has published in reputable law journals. Lihini is a past member of the Editorial Board of KDU Law Journal. She is also a Visiting Lecturer at the Sri Lankan Associate College of Cardiff Metropolitan University and postgraduate research supervisor at University of Colombo.



### **Eric GAN Kok Wah, Singapore University of Social Sciences**

Associate Professor Eric GAN Kok Wah heads the IP and Innovation Management Programme at Singapore University of Social Sciences (SUSS), overseeing graduate programmes such as

At SUSS, Eric focuses on guiding students to develop practical skills to manage and leverage intellectual assets for innovation and growth. His teaching and research interests include IP strategy, IP commercialisation, technology transfer, innovation ecosystems, and entrepreneurship. Recognised as a WIPO Expert, he also delivers workshops and courses on IP management, innovation strategy, and the business of IP worldwide. Eric holds a PhD in Materials Engineering, an LL.M. in IP Law, an MBA, an MSc in Laser Engineering & Applications, and a BEng (Hons) in Electrical & Electronic Engineering.



**Wenwei GUAN, City University of Hong Kong**

Atty. Daniel S Hofileña is a founding partner of Kalaw Prasad & Hofileña Law. Prior to founding the firm, he was a Senior Consultant at the Intellectual Property Office of the Philippines. He also practised law with his father, Atty. Saul Hofileña. He finished his Master of Laws in International Dispute Settlement at the Centre for International Dispute Settlement at the University of Geneva Law School. He is the executive director of the ADR Centre of the Emilio Aguinaldo College of Law. He was inducted into the hall of fame of the Intellectual Property Office of the Philippines in 2023. 
**KONG Xing Le, Intellectual Property Office of Singapore**
